Collection of Practices on Educational Mediation

This output offers an overview of the current practices and approaches in the partner's countries used for mediation in education. You can find comparison between the methods and approaches delivered in the partners' countries with a focus on similarities and differences but most of all what works and what do not in different conflict situations. Teachers can benefit from these practices and facilitate students to take on active position in solving everyday conflict situations. The tool is available in English and in the partners' languages.

Design and development of a training program for educational mediators

The training programme for educational mediators (ProEM) will enable learners to acquire professional knowledge, skills and competences to create and maintain a calm and tolerant educational environment for everyone engaged through the use of educational mediation tools.

- Module 3. Tasks of Educational Mediation and Educational Mediator
- Module 4. Psychological Skills in Educational Mediation
- Module 5. Educational mediation between peers

Training Programme for peer mediation Peer ProE

By educating students to be in a position of educational mediators, children and adolescents will learn the following topics: how to apply constructive methods in conflict resolution; how to apply nonviolent communication; and how to reach acceptable solutions and agreements in conflict situations.

- Module 1. Meaning and significance of conflicts
- Module 2. Communication between peers
- Module 3. Principles and tasks of educational peer mediation. Co-mediation.
- Module 4. Main steps in conducting a school mediation session between peers.
- Module 5. Nonviolent communication

Training for Educational Mediators in Sofia (Bulgaria)

In July, 2022, participants experienced in school mediation and educational field from the partner countries (Bulgaria, Greece, Portugal, Romania and Spain) joined in a training for educational mediators in Sofia. The training allowed professionals to acquire professional knowledge, skills and competences to create and maintain a calm and tolerant educational environment for everyone engaged through the use of educational mediation tools.
